Mike, Mark

We submitted to Planning on 30 June. It has taken a while to get the mock-up installed and a response from the Planners (23 July), so we are on the back foot in terms of time. They are meant to issue a decision in 8 weeks.

Note the proposal to simplify the joints by taking out the birdsmouth on the pilaster (attached). I was hoping for a similar fixing detail that was used in Kilburn: [Picasa web album](#).

I think the corner cassettes need some thought, and we will need to submit detailed drawings of the cassette assembly.

GRC was originally specified but until last week we were pursuing a brushed look. We are looking for something that is similar in colour and tone, and which will resist impact. I will contact BCM to discuss.

The comments regarding the low level cladding from the planners were as follows:

"When we were on site I again raised the issue we found at Kilburn where the panels, even though cassette panels, were damaged and dented, presumably by refuse carts and other large servicing movements. While you have confirmed that the panels will not go to ground, drawing 1279_PL_312 states that the low level pilasters will be completed in brushed stainless steel. We will need to see details of how these will be attached to ensure that they will be robust enough to cope with the activity at this ground floor.

I am aware that this material submission is part of a formal approval of conditions application rather than a pre-app. This will have to be taken into consideration when deciding how we progress these issues in relation to timetable and consultation."

We could also consider the Marley Equitone boards: [Tectiva](#) or [Natura](#), but these look very raw, or "low quality" to the Planners.
