Please find attached revised typical windows showing reduced qty of trickle vents as agreed with Neil 14.01.15.

Do we have an update yet on the restrictor requirements? We are currently working on keyed handles to the side hung windows so they cannot be opened unauthorized. It looks like additional restrictors would have to be face applied Jak Loc (keyed)!

Note that we are supplying the panels to the kitchen windows in one piece for your M&E contractors to cut and fit extract vents as necessary.
