Please see attached. Firstly Harley's marked up sketch and then my plan cartoon showing Harleys proposed window in red and with the symmetry restored (blue). Because of the way the way the window frames come together (photograph of mock up for reference) the space between the two opening frames is only about 10mm. This is not a problem when the wall is cut away as a hatch but would not work if a tenant wants to take the wall right up to the frame....

Following my conversation with several of yourselves today. The following is a list of actions that we need to do in order to finalise the window design issues.

- Mark - Will contact CEP to put all Type 10 (east & west middle bay windows) on hold and confirm what Type 10 windows have actually be fabricated.
- Neil - Will review the Type 10 window layout and confirm the requirements by close of play tomorrow.
- Kevin - Make design alterations if required to Type 10 and corresponding lower floor bays following response from Neil as above.
- Ben – Find out the window restrictor options for the smaller side hung windows so they are in line with clients requirements (100mm restriction) and report back

With the trickle vents no longer required the symmetry to the middle window is not in line with the planning drawings and it is better to return to this position. (Opening in wall at kitchen so alignment with wall is less critical behind).
