We have left the head detail as is, as Rydon's intend to box in the steel at the same level as the ceiling in the walkway.

All items in white as per the internal colour ref.

Additionally we attach the joint detail at the top of the GRC column casings (drg 306).

We have shown the drip profile colour matched to the cladding rather than GRC, please confirm your preference.
