Bruce,

Following our discussion about the sanitary provision for the boxing club I understand that one open-plan changing room is proposed, with an adjacent unisex accessible changing / room shower. This is acceptable provided that only single-sex sessions are held in the club.

I was previously concerned by the fact that the large changing room was indicated as being for males only and there was no female facility, and thereby women and girls would be excluded. This would have been discriminatory on grounds of gender and not acceptable.

Comments on the sanitary ware schedule are also attached. I note that the unisex changing room is called 'male change' in the schedule and recommend that enough cubicles are provided for when all-female sessions are held.
