1.	CW confirmed that works are approximately 6 weeks behind schedule whoever this is not	
	considered critical at this stage.	
2.	The sample windows and the heating set up will be ready by Christmas for consultation with	
	Residents.	
3.	CW confirmed that that the replacement windows sizes are not changing from the current specification.	
4.	CW confirmed that there will be a meeting held to discuss the handover of the new boilers.	
	Cofely will work alongside Rydons to ensure the smooth transition. The order of installation of	
	the new heating systems in flats will now be done by vertical riser rather than by floor, as this	
	has the benefit of being able to isolate each riser. This has resulted in a change in Rydon's	
	programme of works.	
5.	CW highlighted that there could be a potential issue in regards to lifts having to be placed out	<u> </u>
	of service to allow works for access to the new floors/ flats.	
6.	Once completed, CW to send briefing note to PM re: Charging arrangements for the new	CW
	heating system.	
7.	CW confirmed that LFB are aware that the smoke vents are not fully functioning.	
8.	CW will be meeting with David Gibson and David burns regarding stock programme data for	CW
	the concierge services.	
9.	There are no reported issues at present regarding vulnerable residents or residents who	
	hoard possessions.	
10.	CW confirmed that once noisy works are completed respite area will move fro Whitchurch	
	house to flat 145 Grenfell Tower.	
11.	CW to undertake further work alongside RBKC planning in regards to the notice in regards to	CW
	the change in window size.	
12.	CW confirmed that the demolitions works had been slow to date with Rydons however the	<u> </u>
	works were under the planned expenditure.	
13.	SR queried what the allocations policy will be for the new flats. SR to find out more	SR
	information	
14.	CW highlighted that some flats have had additional bedrooms in place at the time of the visit	CW
	which may cause some issues in regards to heating. CW is waiting for an updated list of the	
	effected properties from Rydons.	
15.	KS queried whether it would be possible to bring forward kitchen and bathroom works for	CW
	properties occupied by hoarders. CW to check where Grenfell is on the 5 year investment	
	programme.	
16.	CW to liaise with David Gibson in regards to the risks involved with ordering the new windows	CW
	prior to the final planning being granted.	
17.	CW to chase Silk and Mackman re: Front door fault.	CW
