Hi Siobhan

According to our last list the fire marshals for Grenfell were Victoria and Adelola. I realise Adelola relocated and Victoria off just now but we do train the estate officers and the estate inspectors annually in fire safety training so any of them should be able to act in this capacity. The important thing for everyone to know about fire procedure at Grenfell is that with regard to the residents there is a "defend in place / stay put" policy meaning that unless the fire is within their flat - in which case they should, of course, evacuate immediately closing the flat door behind them, exit the building and ring the LFB - they are safe to initially remain in their home. However, the policy regarding the staff areas is that on activation of alarm they should be evacuated immediately.

On a related note can you please advise who carries out the weekly test on the Grenfell fire alarm. If there is a training need which is preventing this from being tested then please let me know and I will ask Ricki to sort
