Peter,

I would like to drop a brief note recording our discussion on site this Monday, and circulate it to the team.

I have spoken to Mark Watterson who agrees that an early meeting with you and the Planners (Ed George & Richard Craig) will be useful once there is more clarity on the nature/scope of the changes proposed, even if we are to withdraw the application.

• The VE proposals forwarded 18 March (Option 2) probably represent the TMO's objectives, ie:

• Boxing and Nursery stay where they are. (Boxing Club pictures attached)

• New Residential at Walkway and Walkway +1, with new fire escape stair to ground. There is no scope to extend the existing stair to ground because of the electrical intake room below at ground level and the geometry of the stair which discharges into the lift lobby at Walkway level.

 \cdot Lift access to the mezzanine may be possible from the main lifts but the phasing complications will be considerable which is why we did not pursue it.

 \cdot The TMO propose to not allow public access to Grenfell tower, omitting the need for a bridge and new lift to the tower. The project needs to allow for a new access control system.

 \cdot Studio E feel the loss of the stepped ramp, without some form of replacement will be challenged by the Planners.

 \cdot Studio E believe something more than the bare minimum to insulate the building will be necessary to satisfy the Planners as to the appearance of the building.

• The TMO would like to consider access across the estate – for instance controlled access to the walkway.

• A meeting is proposed for next Friday @2pm with Appleyards to discuss next steps.

The walk down Barandon Walk was interesting. Please see attached Contact sheet. The attached sketch, "Lancaster West Access.jpg" illustrates how it has been subdivided and the importance of the existing walkway as the primary
