


I have not seen a copy of the latest KALC newsletter.

The only delay in the Grenfell refurbishment is that we extended the tender period by 2 weeks. However, we still anticipate a start on site in Spring 2014 as we have communicated to residents and the Board.

Tenders are currently being evaluated. The current proposed date for interviews is Friday 7th March 2014. Are you available on this date?

We still aim to get to Board in March for approval of the preferred contractor – this is challenging, but I hope we can do it.
