Hi Robert

Apologies for the delay but I wanted to check with our Fire Risk Assessor before I responded to you.

I can confirm that it is our understanding that we do not have any blocks with cladding of the nature described in the LFB's letter (which was present at the Shepherds Bush tower block). Grenfell Tower did have external cladding panels fitted as part of the recent refurbishment work, however, our assessor investigated thoroughly the details of the installation with the contractor (Rydons) when the works were on site and he is able to confirm that this complies with the requirements of the current Building Regulations.
