Please find attached picture of rotten black bag dropped on the floor next to the Clute for four days and next to my front entrance door. The doctor told me that, this could easily spread diseases and can cause serious health hazard.

I was trying to call the TMO out of hour service ref: 2198394 at 8:20pm and 9:10pm dated 20.01.2016 to get their attention for them to send someone to remove them but without any success.

I strongly believe that and had years of bad experience most importantly during the catastrophic power surge at Grenfell Tower. The TMO's out of hour service are useless and waste of money.

I requested lady call Lynn, patsy and Eileen of out of hour service to provide me the contact detail of the complaint they are going to forward to the TMO so I can follow up first thing in the morning and they are unable to do so. I also requested them to forward the details to some individual but they refused my request. I also requested them to give me the contact detail of the Care taker of Grenfell Tower(Lancaster West Estate) and are not willing to do so.

As you may know I have been victim of this kind of anti-social element many times before and the Local TMO and the estate officer and the Area manager Ms Siobhan Rumble failed to protect me. I have been paying service charges for them to provide me the standard of services and thousands occasion they have failed to do so. I have hundreds of pictures I intend to share with wider audiences soon.

First instant I request you to look into this and please let me know.
