1.I, John BARWIS am a Watch Manager (WM) in the London Fire Brigade. I have been in the London Fire Brigade for 26 years. I have held the rank of Watch Manager for 10 years. During these years I have completed many level one fire investigations as an officer in an operational role.

- 2.I have been working in the London Fire Brigade Fire Investigation Team since 2015. During 2015 1 undertook a three week Fire Investigation course, consisting of two weeks theory training with 'Bureau Veritas' and a one week residential practical course in Fire Investigation with 'Gardiners Associates'. This was followed by a six month training secondment where I had to prove competent in the various job related roles. I took up a permanent position within the Fire Investigation Team in November of 2016. I also have a level 7 Certificate in Advanced Investigative Practice.
- 3.My principal duties involve the examination of fire scenes to determine the area of origin, the cause and to observe how the fire and people behaved. I have investigated approximately one hundred and seventy fires in my current role.
- 4. This statement refers to a PowerPoint presentation that I created on the 4th July 2017.
- 5. Whilst reviewing thermal image camera (TIC) footage taken by operational crews at the Grenfell Tower fire on the 14th June 2017, I found footage that showed the first and second BA crews from North Kensington and Acton fire stations, to enter Flat 16, Grenfell Tower. The TICs had been collected from fire stations by the LFB Fire Investigation Team in the days following the fire.
