At the request of the Public Inquiry into the Grenfell Fire, this is my statement regarding CCTV images of Behailu KEBEDE taken from, and by the front entrance lobby of Grenfell Tower on the night of the 13/06/2017.

I am currently working within the OP NORTHLEIGH CCTV unit which deals with all the CCTV images and other related footage, obtained, and relating to the Grenfell Tower Fire.

I have been attached to the CCTV Strand of the Grenfell Investigation since August 2017, due to my prior identification work with the Super Recogniser Unit and other like work with SC01 on Operation Purple Wave - the investigation into the murder of Alice Gross.

My role involves identifying the last movements of the deceased at Grenfell Tower, from CCTV taken from that building, and the subsequent creation of a timeline in that regard.

This work has made me very familiar with all the resident's movements in the Tower, prior to the fire, and best places me to deal with any subsequent queries re resident's movements on the CCTV, both from a facial recognition point of view and also my familiarity with the CCTV having viewed it daily for months.

In clarification there are 5 cameras covering the entrance / lobby and lift areas of Grenfell and

the standard or quality of that footage is excellent ie HD standard.

Entry to the tower is fob key access only unless a resident is buzzing you in.

The correct time is in WHITE at the bottom left of screen.

In this statement I will detail the movements of Behailu KEBEDE who was a resident on the fourth floor

of Grenfell Tower on the night of the tragic events of 14/07/2017 and from whose room the fire

emanated, after his fridge caught fire.

In accordance with the Public Inquiry Teams request I have identified the following movements made by

Mr Behailu KEBEDE prior to the fire on that night of the 13/07/2017.

I note that Mr KEBEDE exits Grenfell Tower the Tower at 18:17:16 hours and later on returns to the

building in the same clothing at 23:46:10 hours and the relevant footage in this request is the CCTV

footage from the entrance, and lift lobby - sole exit and entry point of the tower.

On KEBEDES return into the building, he does not and is not seen to make any further movements until

the start of the fire.
