I commence this 2 page statement at 1630 hrs on Wednesday 14th June 2017 at Redhill Aerodrome. This statement is in relation to video footage obtained using the police helicopter's video camera system. I am a serving Police Sergeant employed by Kent Police currently seconded to the National Police Air Service (NPAS) as a Tactical Flight Officer and Base Manager at the Redhill Aerodrome base in Surrey.

At 0830 hrs on Wednesday 14th June 2017 I was on duty on board a police helicopter when I attended the area of Grenfell Tower, W11, London following reports of a large scale fire within a residential high rise tower block. The incident had been declared a major incident and numerous emergency services were in attendance. I was crewed with TFO PC Gavin HOLMES and the pilot was Capt SAMUELS.

At this time I caused a video to be recorded using the on-board camera system. During the time in attendance I used the on board camera to obtain footage of the scene. At 0945 hrs I stopped the recording and left the scene, handing over subsequent recording to a further police helicopter NPAS 13 which had arrived to relieve us.
